

SCVA POLICY ON RECRUITING SERVICES AND VIDEO TAPING.

Due to the increase in complaints from parents whose minor children have appeared unknowingly in video taped footage of unauthorized recruiting services, to comply with the philosophy of the USOC's SAFE SPORT initiative, and in an effort to protect the privacy and safety of all participants at SCVA events, please note the following updated policy regarding recruiting services and video taping. The SCVA is not responsible for unauthorized, third-party vendors soliciting or selling services for recruiting or video taping. These companies are independent and not associated with nor endorsed by the SCVA in any manner. Furthermore, the SCVA is not responsible nor liable for individuals video taping or otherwise capturing footage of matches for personal or club use. If your club, or any participant in your club has engaged the assistance of any recruiting service or video taping company, YOU MUST REGISTER THIS COMPANY WITH THE SCVA and take full responsibility for the action of this company while present on property for any competitions hosted by the region. Unauthorized companies may be asked to leave the premises. In order to register the company with the SCVA, please note the following:

- Submit, in writing, a letter of authorization by the club that includes the team name and name of individual(s) using the service for that particular event.
- The company is not authorized to distribute or display any promotional materials on-site without express written permission by the SCVA. At no time may any device be on the court surface/field-of-play, or attached to any part of the net system, scorers table or team bench, or in any manner fixed to any overhead fixtures, furnishings or building catwalk, etc.
- The company agrees to comply with the rules and regulations set forth by the SCVA for use of tripods or other commercial recording equipment. Such rules and regulations may be subject to revision on-site as a result of fire marshal or venue management requests.
- Submit a copy of the company's license to do business in the state where the event is held.
- Submit a copy of the company's proof of insurance, naming the SCVA, USA Volleyball, and the facility in use as "Additional Insured."
- Submit a copy of the film waivers that must be signed by all other parties who may be captured in your footage, including minor children (requires parent or legal guardian permission). Complaints from spectators or participants will be redirected to the club and company.

If your club, or any participant in your club (including other coaches, technical staff, family and friends) use personal recording devices to capture match play, you are personally responsible for obtaining proper rights and clearances from any individual from the opposing team who may be captured in your footage. You may be asked to remove your recording device if any individual or parent of a minor participant makes a formal complaint with the tournament officials. Please advise your parents that they must keep all tripods or similar devices clear of any main walkways and off court surfaces. Personal recording devices may not be attached to any part of the court playing area, including net systems, banners, team bench, etc. The SCVA Event Staff may remove any items improperly placed, at the request of the officials or tournament staff, and such items will be placed in lost & found. Failure to comply with the request of tournament officials regarding this matter may result in further disciplinary action to your team or club.
