**NEW OFFICIAL'S TRAINING CAMP**

All NEW Officials to the S.C.V.A. must attend a Training Camp consisting of one classroom clinic and one on-court training day.

All Referees are required to take the Mandatory SAFESPORT modules prior to attending the clinic of choice.

**R.S.V.P. is REQUIRED for attendance of the clinic.** You must email the SCVA office at [mel@scvavolleyball.org](mailto:mel@scvavolleyball.org) ; and/or [info@scvavolleyball.org](mailto:info@scvavolleyball.org)

**Check - In will be available 30 minutes prior to the start of the clinic.** All paperwork must be filled out completely and monies turned into the office 2 weeks prior to attending the clinic.

# 2019/20 SCVA New Officials Training Camp

This camp is required for all first year officials with SCVA. In this camp we will give you the opportunities to acquire the knowledge and tools to be successful as an official with our Association. This document will give you a summarized report of what to expect in the Officials Training Camp.

Please remember you must attend **BOTH** the classroom portion and the on-court portion of the Officials Training Camp in order to be certified with SCVA. You must attend a classroom portion **BEFORE** your on-court portion.

- Classroom Dates (choose 1):
  - November 3rd, from 2pm till 6pm
  - December 7th, from 2pm till 6pm
- On-Court Dates (choose 1):
  - November 24th, from 7am till 2pm
  - December 8th, from 7am till 2pm
  - January 11th, from 7am till 2pm
- Fees:
  - \$105 total for the camp; this includes your \$65 SCVA/USAV Registration Fee

## Classroom Portion Details

1. Attire: please dress in business casual.
2. Breaks will be provided. Lunch will NOT be provided so please bring your own snacks and water.
3. The classroom portion will introduce the officials to the basics of the game of volleyball. We will be watching video training modules and participating in discussions. This includes subjects such as the Court and Equipment, Match Protocol, Officiating Mechanics, Ball Handling, and Scoring. Please bring something to take notes with and pens as you will be scoring.

## On-Court Portion Details

1. Attire: please dress in the approved officials uniform if you have it. If not, dress in either navy or dark colored pants and a white or light colored polo.
2. Make sure you at least bring a whistle. If you have the following it would be a good idea to bring them as well; red/yellow cards, flipping coin, net measuring device, ball gauge.
3. Breaks will only be provided in between matches. Lunch will NOT be provided so please bring your own snacks and water.
4. Camp attendees will be calling live matches. You will work an entire pool (6 matches) with your team and rotate and work each position. You will be taught by experienced instructors, please keep an open mind and incorporate what is being taught to you. Bring note taking methods.
